

In terms of Section 14 (3)(a)/15 (3) (a) of the NCTE Act, 1993, the Eastern Regional Committee granted recognition to No. TC College of Teachers Education, Street/Road - I.T.Road, Vill - I.T. Road, Kangpokpi, Taluka/Mandal - Kangpokpi, Town/City - I.T. Road, Kangpokpi, Dist - Senapati, Manipur - 795129 for conducting B.Ed vide recognition Order No. ER-266.6.7/ID No.-9892/B.Ed/ 2019/59344 dated: 14-02-2019 with annual intake of 100 students.

2. The matter has been considered by ERC in its 306th meeting held on 12th & 13th July, 2022 and the committee *inter-alia* decided as under:-

Accordingly, show cause notice was issued to the institution on 04.08.2022. The institution has not submitted any reply.


3. The matter was again considered by ERC in its 311th (Virtual) meeting held on 11th October, 2022 and the committee *inter-alia* decided as under:-





It is submitted that the name of our institution has been mentioned at Sr. No.37 of the list enclosed under the aforesaid decision. A copy of relevant minutes of ERC is enclosed as **Enclosure 1**.

Sir, at the outset, we would like to inform you that we are running the B.Ed. course since the year 2019, and have complied with each & every requirement / directive issued by NCTE/ERC from time to time, for running the said B.Ed. course. We would like to inform you that recognition for conducting the said B.Ed. course was granted by the ERC to our institution vide recognition order No. F. No. ER-266.6.7/ID No.9892/B.Ed./2019/59344 on 14.02.2019 for conducting the B.Ed. course with an annual intake of 100 students (2 units) from the academic session 2019-20. A copy of the ERC order dated 14.02.2019 is enclosed as **Enclosure 2**.

It is submitted that the said recognition was granted to our institution after the physical inspection of our institution conducted by the expert visiting team of the ERC as per the extent norms i.e. NCTE Regulations, 2014 and subsequent amendments therein, and also after the due verification by the ERC of the supporting documents submitted by our institution at the time of submission of hardcopy of the application and thereafter, in compliance of the letter of intent issued by the ERC. The inspection team and also the members of ERC, found our application fit and our institution eligible for running the said B.Ed. course with an annual intake of 100 seats (2 units). Thus, the recognition was granted to our institution by ERC / NCTE only after satisfying themselves with fulfilment of requisite criteria by our institution and inspection report submitted by the visiting team.

Sir, we would further like to inform you that affiliation has also been granted to our institution by the affiliating university on December 11/2015 (Temporary affiliation, order No.MUA-87/CDC/2013/164)

23.11.2020 for running the said B.Ed. course, and the same has been granted after due verification of the documents and also the physical inspection of our institution. Further, the affiliating university also issued a letter dated 26.11.2020 certifying the permanent affiliation of our institution. It is relevant to state that the affiliating university conducts inspection of an

institution in the likewise manner of ERC NCTE and grants the affiliation only after fulfilling the standards by such an institution, in consonance with norms of the ERC / NCTE and also the State Govt. A copy of university affiliation letters dated December /11/2013 (Temporary Affi.), 23.11.2020 & 26.11.2020 is enclosed as **Enclosure 3**.

So far as submission of PAR is concerned, it is submitted that we have all the infrastructural & instructional facilities including the requisite documents & information for running the B.Ed. course as per the norms of NCTE Regulations, 2014. Further, the recognition has been granted to our institution in the year 2019, when the PAR process was already underway by the NCTE. Thus, it is not out of place to say that recognition to our institution was granted by the ERC, pari materia of the PAR.

Sir, so far as non-submission of PAR by our institution is concerned, it is submitted that despite having all the information / documents, we could not upload the same on the PAR portal within time, due to confusion arisen out of court case in PAR matter and thereafter, when we tried to submit the PAR on 01.04.2022, the process got failed due to some technical glitch / heavy rush on the website of NCTE because the website of NCTE was opened for very short span for submission of documents and thus, submission of PAR could not be done by our institution likewise various other institutions in the State / Country.

Sir, it is submitted that our institution fulfils all the requirements as has been prescribed by the NCTE in NCTE Regulations, 2014. Our institution has all the documents requirement for submission of PAR with NCTE and we are submitting herewith dossier pertaining to PAR documents which contains the approved faculty list, building plan, building completion certificate, land documents in favour of our institution, land use certificate, non-encumbrance certificate, GIS location of the institution, list of staff with their details and documents, details pertaining to admitted & passed out students etc. A copy of dossier containing the aforesaid documents towards PAR is enclosed as **Enclosure 4**

Thus, our institution is having all the information documents required for submission of PAR and accordingly, our institution fulfils all the criteria for running the said B.Ed. course. Sir, our institution is running since 2019 and has never violated any of the norms prescribed either by the ERC/ NCTE or the State Govt. or the Affiliating Body.
